## **Submission Deadline:**

May 16, 2024

<u>DEADLINE FOR APPLICATION</u>: Prospective graduates are required to submit applications for graduation one semester prior to their expected graduation regardless of your intent to participate in the commencement ceremony. The graduation application fee is <u>not</u> required at the time of application. **Graduation Application Fees are Non-Refundable.** 

## **Instructions:**

- 1. Complete information as requested below and return the application, with an approved (signed) degree plan, to the Registrar's Office by the specified deadline date. **All applications must be typed.**
- 2. The name on your University records <u>MUST</u> be the same as your degree. This means that you must correct your records should your marital status change, or you wish to change your name for any reason, providing you submit the proper paperwork.
- 3. Submit proof of payment of the graduation application fee to the Registrar's Office by the specified deadline date.
